





Kaplan, who serves as an adviser to The Merage Foundations, has helped the school develop a network of donors. Be-

fore joining The Merage Foundations, he directed the Wirth Chair on energy, climate change, and community development issues and policies, and served in the administrations of former U.S. presidents Jimmy Carter and John F. Kennedy.
